5. **What Do You Get When You Mix MYN and CERT Together?**

MYN—Map Your Neighborhood—is a nationally recognized 9-step community preparedness program designed to help you and your neighbors know what to do (and not do) immediately following a major disaster. It takes about 3 hours and is conducted in your home with your immediate neighbors. CERT—Community Emergency Response Team—is a Homeland Security standard program designed to prepare you to respond to major disasters within your community and beyond. In Los Angeles, it is a 17½ hour program taught by LAPD personnel at a general meeting location. Disaster strikes! You and your neighbors swing into action. Later, CERT volunteers appear (remember, LAFD, LAPD, ambulance, utility crews are *NOT COMING!*). How will you work together? Attend and hear from one of the leaders of the first-ever MYN-CERT combined resource drill recently conducted in the Mt. Washington Jessica Neighborhood area.

6. Possible discussion regarding best practices for preparing for and coping with disasters or large-scale emergencies. The public is invited to contribute to this discussion.
