**A veteran of the United States Marine Corps, Mr. Smith has been certified by the City of Los Angeles and LAPD OVB (Operations Valley Bureau) training cadre to instruct *Run, Hide, Fight – Surviving an Active Shooter*. He trains both at the Getty and volunteers to teach around the city.**
