    1. Motion: Regarding CPC-2016-837-SP-MCUP and CPC-2016-838-DA, a proposed regional shopping mall on Rinaldi west of the current one.
      - \* That GHNNC write a letter to the City Planning hearing officer, May Sirinopwongsagon , supporting the Porter Ranch Neighborhood Council's generally favorable recommendations;
      - \* recommend that the City require the Developer to make good on the agreement to dedicate a 2-acre site to the City for future development of services, even if the City today does not have the funds to build on this site (a projected library, Community Center, and a child-care facility). There is no reason to relieve the developer of this agreed-upon responsibility. The City should realize that many years hence it will be immensely harder to re-acquire land for such uses, and the land can meanwhile stay undeveloped;
      - \* accept the Developer's offer to have a 4,000 sq ft community room available on the second floor of the shopping center, as long as it will be publicly available including evenings and weekends;
      - \* recommend that the City look into additional traffic mitigation, including additional on and off ramps to the 118 Fwy and widening of the streets adjacent to the project.
    2. Motion that GHNNC write a letter to Devonshire Division and CD12, asking for increased enforcement of RV parking rules, and post the necessary signs in the proposed enforcement areas.
