Being a Good Neighbor—Report Violations to 3-1-1

Leaf Blowers may not be used before 7:00 am or after 10:00 pm. (LAMC 112.4(c))

Construction in residential areas limited to the hours of 7:00 am to 9:00 pm, during the week, and 8:00 am to 6:00 pm on Saturdays. It is banned on Sundays. (LAMC 41.40(a)(c))

Tampering with or stealing refuse, rubbish, and salvage from containers placed at curbside for collection is prohibited. (LAMC 66.28)

Properties must be free from graffiti, trash, debris, and overgrown vegetation. (LAMC 91.8104)

Items such as indoor furniture, plumbing fixtures, construction, or auto parts are not to be stored in the yard. (LAMC 12.21A(a), 12.08A, 12.21C1)

Vehicles should not be parked in the front area of the property, except in a designated driveway. (LAMC 80.71.3)

Home Auto Repair, other than from minor emergencies, which must be completed within 24 hours, should be done within a building or in an area which is entirely enclosed from view by a wall or fence. (LAMC 12.21A1(a), (12.21A8(a))

Trash/Recyclables/Yard Waste/Manure containers can be set out on the curbside no earlier than 6:00 pm the evening before collection, and are to be removed no later than 8:00 pm following collection. (LAMC 66.27)

Disposing of large items, including furniture, water heaters, etc., out on your curb or parkway to be picked up can only be done by calling 3-1-1 or (800) 773-2489 and asking for *bulky item pickup service*. They will tell you when to put things out and when they will pick them up. (LAMC 66.27)

Litter is to be picked up from your property and placed in appropriate trash receptacles. (LAMC 57.21)

Planning and Land Use Management (PLUM) Committee

The PLUM Committee studies and makes recommendations about issues of land use in our community. It reviews requests by homeowners, developers, and businesses that may affect our area and our stakeholders.

Sometimes it is about a business or developer that wants to rezone a lot to do a particular project in our area. The PLUM Committee hears the proposal, offers suggestions and advice on making the project fit better into the community. Sometimes there is a fit to some area need; sometimes the proposal is out of character with the area in terms of size or use. Perhaps it is a project that many residents do not want. When there is little controversy about a proposal, the committee works with the applicant to make the project as good as possible, and then the committee recommends to the GHNNC Board whether the project should be supported. It is important to realize that the full GHNNC Board, after due discussion, makes its determination and then advises City agencies of its decision. An example is the proposal for a new childcare facility on Woodley Avenue—this fit into a current neighborhood need.

When a project is controversial, such as the proposal for an eldercare facility in a residential area, with a large proposed footprint and dense occupancy, the committee also publicizes it to stakeholders for their input, may hold additional public meetings, and may propose changes to the developer, which may include a mitigation plan. After due diligence, the committee makes its recommendation to the Board. In the recent instance of the proposed eldercare facility, the developer eventually abandoned its plans.

At times homeowners may have an issue with, or want to build on, their lot. If this falls within City guidelines for the zoning, PLUM does not get involved; but if it poses a problem for neighbors, the committee works to either improve the project so it is a better fit, or recommends that the GHNNC Board request applicable City agencies to deny the project.

Sometimes a City ordinance or conditional use permit (CUP) is flagrantly violated. An example is the building of high block walls that encroach on an equestrian trail counter to the City's easement and the City's conditions for the trail. Then the committee alerts City officials of the particular enforcement agency—such as Bureau of Engineering or Department of Building and Safety. Another example would be a liquor store that operates beyond the hours approved in their conditional use permit, or a school that uses loud public address systems that bother neighbors.

More current issues are those that deal with placement and appearance of cell towers, adding lights to the youth sports fields on Balboa Blvd., and O'Melveny Park sporting uses. PLUM works with organizations and residents to balance concerns for safety and the quiet use of their properties.

The PLUM Committee depends on stakeholders (homeowners, residents, people who work in the area) for involvement and assistance. You are the eyes and ears of our community and we want to work with you for our positive existence in this wonderful community. Residents' Association Representative

residents' associations. These vary from maintenance of and access to horse trails, to major developments that will bring more traffic, congestion, and noise.

Neighborhood Councils have a great deal of influence in Los Angeles City policy. Neighborhood Councils (NCs) were created by City Charter to *promote more citizen participation in government and make government more responsive to local needs*. There are often different opinions on how money allocated by the City to NCs should be spent, and which policy positions should be recommended to our elected officials. NCs also submit Community Impact Statements (CIS) that become part of City Hall motions. If you would like to have a say in your community, please vote in our elections. Even better, step up and run for a Board seat, or participate in one of our committees or events.

GHNNC has all 25 board seats up for election this year. Each seat is for a 2-year term. Although the election day is **April 9, 2016**, the candidate filing period ends on **February 9, 2016**. Voting will be at the Granada Hills North Neighborhood Council office, 11139 Woodley Avenue, Granada Hills, from 10:00 am to 2:00 pm. Please vote! You will need to show ID, and be able to demonstrate your qualifications to vote for particular board position(s). For more information on our elections, please visit

Patriot Oil Community Benefit Trust Fund

The North Valley Coalition of Concerned Citizens Inc., known as the NVC, administers the Patriot Oil Community Benefit Trust Fund. The Trust Fund was established in 2002 as partial compensation to the local community for the oil wells in our backyard. Through several changes of ownership, the companies have continued to contribute annually to the fund, and the distribution of those funds is handled by the NVC. Three of their most recent large projects include funding the *CPR Anytime* training program by the American Heart Association at Van Gogh Elementary, Robert Frost Middle School, Granada Hills Charter High School, and John F. Kennedy High School;

installation of additional security cameras and fiber optic connections in O'Melveny and Bee Canyon Parks; and replacement of the old water fountains with combination water fountains and pet watering stations in those same parks. RoboCalls

Let's face it. Who hasn't received unsolicited robocalls day or night from some company trying to sell you some home improvements or some other type of service or product, and they call you again and again even when you say you are not interested or that you are on the **National Do Not Call Registry**. Illegal robocalls remain a significant consumer protection problem because they repeatedly disturb consumers' privacy and frequently peddle fraudulent goods and services that cause significant economic harm.

There have been recent hearings conducted in the US Senate Special Committee on Aging on June 10, 2015 to examine the proliferation of unwanted calls. Written and oral testimony was taken from affected individuals and from the Federal Trade Commission (FTC) representative. Consumer Reports ran an article on the same which appears in the September 2015 issue titled *Rage Against Robocalls*, which is well worth reading. They confirm much of the testimony offered in the Senate Hearing and offered suggestions and advice under *What to Do When the Phone Rings*, like trying to avoid getting satisfaction from yelling, blowing whistles, dialing 1 to connect with a live person, 2 to be removed from their robocall list, or having a baby babble into the phone. It doesn't work—just hang up. Along with other suggestions, they also evaluated a number of devices under *Consumers Rate Robocall-Blocking Devices* which are specially designed to stop robocalls. It seems that not only landlines are being affected but a growing number of cell phones as well. Disposing of Household Hazardous Waste the Right Way

S.A.F.E. (Solvents/Automotive/Flammables/Electronics) recycling and disposal (no business waste) is available in our community at 10241 Balboa Blvd., Granada Hills (former location of Fire Station 87), and is open Saturdays and Sundays (only) from 9:00 am to 3:00 pm. Collections are suspended during rainy weather.

You are required to remain in your vehicle, so plan accordingly when loading up. Remember, it is against the law to transport more than 15 gallons or 125 pounds of hazardous waste to collection sites. Please pack and secure your hazmat waste properly to prevent tipping or spilling of the waste during transportation. New Renewable Energy Project at Sunshine Canyon Landfill



Sunshine Canyon Landfill is home to a new landfill gas-to-energy (LFGTE) project. The 20-megawatt renewable energy project is capable of generating enough electricity to power nearly 25,000 area homes.

Republic Services partnered with Sunshine Gas Producers, a joint venture between DTE Biomass Energy and Aria Energy, to develop the Sunshine Canyon LFGTE project.

LFGTE projects capture methane from biogas, which is

generated by the decomposition of waste within a landfill. The methane can be harnessed and converted into renewable energy sources that supply the local power grid. According to the U.S. Environmental Protection Agency (EPA), landfill gas-to-energy projects reduce reliance on non-renewable energy resources, such as coal or petroleum. Based on EPA calculations, the carbon emissions prevented by the new Sunshine Canyon gas-to-energy project from entering the air is equivalent to the consumption of more than 100 million gallons of gasoline.

Last year, we held a free community shred event. More than 80 stakeholders turned out to have their no-longer-needed documents shredded. It was extremely successful, so we are hosting another FREE community shred event on **Saturday, March 12, 2016**, from 9:00 am to 11:30 am. Bring your old paperwork, bills, confidential papers, tax returns, and any other



documents you want to see shredded (yes, you can watch) to **Knollwood Plaza, 11846 Balboa Blvd.** in Granada Hills. Paperclips, staples, etc., do not have to be removed, and papers don't have to be removed from three-ring binders or file folders (including hanging folders or those

with Acco fasteners) before being fed into the mobile shredder. Maximum of 5 bankers boxes per family. Up to 5 CDs and DVDs may also be shredded.

Respect Your Neighbors and Our Neighborhood

Signs, signs, everywhere a sign—nailed to trees, pasted on equipment boxes, fastened to utility poles or street signs, taped to signal and light posts, obstructing the sidewalk or placed in the public right-of-way, stuck in the parkway, and ones on private property but which extend into the public right-of-way. They reduce visibility, increase driver distraction, create a negative impact on our health, our quality of life, the environment, and often become trash on your lawn, in the street, and clog the storm drains.



We all want help finding our missing schnauzer, advertising our business, selling our stuff, and showing support for our favorite political candidate. However, such sign posting on public property and in the public right-of-way

is unlawful in Los Angeles City. Call 3-1-1 to report illegally posted signs, visit bss.lacity.org/request.htm, or use the

MyLA311 smartphone app. Each year the Bureau of Street Services removes about 300,000 signs, at a cost of over \$60 million.

Key points to remember for garage sales: A maximum of five events, each not exceeding 2 days, are allowed per year. Sale items must be **used** only, no new merchandise. Sales are not allowed on sidewalks, streets, parkways, or any other public right-of-way. Hours are limited to between 9:00 am and 5:00 pm.



Where can you legally post? Within or on your own property, or other private property with permission of owner, inside store front windows (with permission), and community bulletin boards. Social media sites work extremely well in promoting your event. Other restrictions (such as size, length of time posted, physical shape, placement location, and quantity) may also apply.

Emergency Preparedness Meetings in Granada Hills

Third Tuesday of the Month, 7:00 pm



Perhaps you remember this iconic “fire on the water” image from the January 17, 1994 Northridge earthquake in our own backyard on Balboa Blvd. near Lorillard St. in Granada Hills. That’s 22 years ago! How long were you without

running water? Sewer services? Electricity? Could you stay in your home? Were you prepared? Remember, we’re all in this

together, and we will need each other’s help during and after the next big disaster or terrorist attack. Come to our Emergency Preparedness meetings on the third Tuesday of the month, 7:00 pm, at our Neighborhood Council office, 11139 Woodley Ave., Granada Hills. Get to know your fellow stakeholders and neighbors, share ideas on preparedness, discuss topics of interest relating to being prepared, express your concerns, and hear guest speakers on a myriad of topics. We’ve heard how to prepare our pets for disasters, how the physically impaired can be better prepared, how to use FRS/GMRS radios, about the dangers of EMPs, how to protect yourself and family after a release of nuclear radiation, how to safely store water, and what safety precautions to take around natural gas. Sunshine Canyon Landfill-Community Advisory Committee (SCL-CAC)

The SCL-CAC serves as the liaison between the landfill operator “and the community and as a means for the community to communicate with the Regional Planning Commission and other regulatory agencies on an ongoing basis regarding issues involved in the development and operation of the Landfill.”

At their March 12, 2015 meeting, **Dr. Cyrus Rangan**, Director, Bureau of Toxicology and Environmental Assessment, County of Los Angeles Public Health, spoke about the effects of odors. The entire speech and further information can be found on www.scl-cac.org. Below are some excerpts from his comments.

“And so, when I hear about a situation like this, when we are talking and emphasizing this notion about odor complaints, that’s where for me it’s a big focus, and it really does actually cause adverse health effects, not necessarily outcomes, but have adverse health effects.... When you are talking about something like odors; no I’m not saying you can’t get cancer from smelling an odor. But what I can say is that, yeah, can it cause eye irritation, nose irritation, mouth irritation, throat irritation, nausea, light headiness, a feeling of ick. All those

kinds of things. Yeah, of course you can. And do I as a physician consider those to be real health effects? Real physiological effects? Yes, because they are real.

“So...I’ve seen that kind of statement before in lots of letters from lots of different kinds of industries and agencies, about you know, ‘our facility or this facility or that facility does not pose a threat to public health.’ You know those kinds of wordings...threat to public health. I’ve seen that kind of wording a lot. But, when it comes to something like live odors, and the kinds of complaints that you have voiced today, well, those are public health as far as I am concerned.

“The World Health Organization and the CDC have been coming out recently with statements saying that things like odors and other things of that scale that affect people’s daily quality of life or daily living are considered Public Health issues.”

The SCL-CAC meets every other month (next is Mar. 10) on the second Thursday, 3:00 pm to 5:00 pm, in the Fairway Room at Knollwood Country Club, 12024 Balboa Blvd., Granada Hills. The public is invited and encouraged to attend.

Faith-based Information

The faith-based representative and faith community attended several safety sessions offered by the LAPD. These included sessions on domestic violence, and safety of facilities and members, along with handouts.

There is much that can and should be done in this area, and additional meetings are being planned.

Los Angeles Police Chaplin **Sgt. Crawford** retired in December, 2015 after over thirty years with the force. Best to you in retirement.

For years, we've been working with various City departments to

make it easier to store disaster response items on religious properties. In most cases, the cost of necessary permits and fees are extremely high. We have yet to find a fair resolution with the City. If these kinds of supplies are not on hand and readily available to our stakeholders at the time of a major disaster, such as the anticipated 8.2 magnitude earthquake along the San Andreas fault, an opportunity to provide for the greater good, when police, fire, paramedics, and utility crews won't be coming soon, will have been missed.

Neighborhood Watch News and Crime Update



Do you make your house looked lived-in when not at home? Do you keep your doors locked and some lights on all the time? Do you know your neighbors? Do they know you? When shopping, do you put packages out of sight in your car? These are questions we asked of you a few years ago.

We previously introduced you to the national Neighborhood Watch program, as well as our own. Many of you formed Neighborhood Watch groups in your neighborhoods. If

you've been procrastinating, now is the time to join. Early this year a rash of crime hit our area hard. Most were residential burglaries and theft off/from cars. Be alert! Look ahead. Engrave your valuables with your driver's license number to help with retrieval if stolen. Get to know who belongs in your neighborhood, and more importantly, who does not.

To join or form a Neighborhood Watch group and learn how to protect yourself and your neighbors, contact your Senior Lead Officer (SLO), or attend their monthly meeting. Englander Demands SoCal Gas Recognize Adjacent Communities Affected by Leak



On January 13, I submitted a motion asking that the Southern California Gas Company recognize and extend their relocation efforts to include the immediately adjacent communities of Granada Hills, Chatsworth, and Northridge and that residents requesting relocation from

those communities be treated with the same respect and priority as anyone with a reasonable relocation request.

Overwhelmingly, many residents of the adjacent communities of Chatsworth, Northridge, and Granada Hills are reporting that they too are experiencing symptoms related to mercaptan exposure. Unlike residents of Porter Ranch, however, they report that they have tried to take advantage of relocation assistance and have either been denied or relegated to a non-priority status, or simply have not received return phone calls, thereby extending their considerable exposure and suffering.

Odors and airborne chemicals don't stop at community lines or ZIP code boundaries. It is critically important that all reasonable relocation requests be accommodated by SoCal Gas and that everyone experiencing symptoms be treated equally.

The **Customer Resource Center**, which I requested the SoCal Gas Company open in November, is now open at 19731 Rinaldi St., Porter Ranch, Monday through Friday, 10:00 am to 8:00 pm. This physical storefront, which is ADA accessible and multilingual, provides a one-stop portal of information for all

members of the public. Several hundred residents per day have already utilized this resource. The SoCal Gas Company will be expanding this center with the space next door to accommodate growing requests.

To report a smell or potential gas leak, call the SoCal Gas Company at (800) 427-2200 and call the South Coast Air Quality Management District (SCAQMD) at (800) 288-7664 or go online: <http://www.aqmd.gov/contact/complaints>.

For residents who wish to relocate, SoCal Gas is providing free, temporary housing accommodations, including locations that can accommodate residents with disabilities and people with access and functional needs. For residents with pets, they have arranged pet-friendly locations. To receive temporary housing accommodations, call (877) 238-9555. If you feel you have suffered illness, harm or injury as a result of the Aliso Canyon Gas Leak, call the Claims Department at (213) 244-5151, or fill out the online form at <https://www.socalgas.com/about-us/claims>. Highlights from the 8th Annual Fair:

- ◆ Families from over **52 Neighborhood Councils** and all **15 City Council Districts** registered online.
- ◆ Of those responding, 77% said they would be attending for the first time.
- ◆ Our Speakers Series, with **LAFD Captain/Paramedic Stacy Gerlich, Seismologist Dr. Kate Hutton, LAUSD OES Dr. Jill Barnes, Survivalist Mr. Tim Kneeland, and MySafe:LA's Mr. David Barrett**, experienced near-capacity attendance.
- ◆ **Cedars-Sinai** screened 56 donors and collected 50 units of blood (68% increase in blood collection over prior year).
